Meeting Called to Order: Jen Mazur called the meeting to order at 6:01 pm. Chad Neiswender seconded the Motion.

Treasurer's Update: Chris Rayburg provided the final budget. The season ended with a balance on \$49,021.14. This does not include coaches salary for the 2023-2024 season. That is approximately \$21,000.00.

- 4. We were unable to find an interested party in the secretary position. Chad Neiswender's two-year term has ended. The board will seek an interested candidate at the beginning of next season. Thank you to Chad Neiswender for his years of service to the GMPAC Board.**

5. Allison Shollenberger will take over concessions next year. Thank you to Jessica Mock and Kevin Mock for their years of service running the concessions for GMAC.
6. Jen Mazur will no longer be serving as the USA parent liaison.
7. Record board is for GM Student Athletes Only. We currently do not have a record board for participants that reside outside of the school district. The board will ask Kyle Kuser how he would like to move forward with this.
8. Kyle Kuser will be asked to fix the record board for a 9-10 swimmer. Per the Request of Adreinne Miller.
9. Check with Kyle Kuser if we can have aquatics representation at the Mustang Learning Expo on 3/26 as per the request of Adrienne Miller. The board feels this is a coaching or aquatics directors responsibility. The board is willing to have representatives or information disseminated at each of the Open Houses at the elementary and intermediate levels.
10. Next year, Ashley Shannon is the contact person for anything that needs to go on Peach jar.
